- Meet the U.S. Small Business Administration Size Standards based on NAICS

## Student Intern Criteria:

Students interested in participating in the Small Business Internship Fund must meet at least one of the following criteria:

- Be a resident of Lackawanna County currently enrolled in a college or university
- Be a currently enrolled student of a Lackawanna County college or university
- Be a currently enrolled student of a Chamber member college or university
- Be a resident of Lackawanna County that is a 2020 College Graduate
